**GRANT OF SHORT SERVICE COMMISSION IN
THE ARMY MEDICAL CORPS : BATCH- 2022
REGN NO. 202208SSC1790**

1. Reference your application for grant of Short Service Commission in the Army Medical Corps.

Appointment and Tenure

2. You have been selected for grant of Short Service Commission in the Army Medical Corps in the rank of Capt or equivalent under the terms and conditions of service laid down in Army Instructions (AI) 75/78, as amended, for a period of five years in the first instance. The grant of Short Service Commission in the Army Medical Corps is extendable up to a total period of 14 years including previous AMC service, if any, through two further spells of 5 years and 4 years respectively, subject to overall performance and meeting the laid down eligibility criteria. The tenure of Short Service Commission will not be extended beyond the age of 55 years or 14 yrs service whichever is earlier. This commission will be provisional in the first year subject to receipt of positive verification of your character antecedents from the Civil/Police authorities, that you are fit for Commission in the Army Medical Corps, with a subsequent notification issued in the Gazette of India.

Reporting and Commissioning

3. You are requested to report to the Commandant / Commanding Officer of the unit mentioned at Para 20 below **at the earliest but not before than 17 Apr 2023 and not later than 04 May 2023**. If you fail to report **within the stipulated time period as above, this appointment letter will automatically be cancelled**. Your date of commission will be the next day of your reporting, provided you are found medically fit. Please note that:-

(a) **Your seniority for pay and promotion will be from the date of Commission. The inter-se seniority for officers commissioned on the same day will, however, be determined by the merit in selection.**

(b) You will be on probation for a period of one year from the date of your Commission. In case you are reported upon during your probationary period as unsuitable to retain your commission, your service may be terminated at any time before or after expiry of the probation period on one month's notice.

(c) **Eligibility for Permanent Commission.** You will be given three chances for taking up the departmental examination for permanent commission after completion of two years of SSC service and before completion of nine and half years of SSC service provided you fulfil the condition of eligibility laid down in AI 74/76 as amended subject to the condition that not more than two chances shall be given in one tenure of five years. During second or subsequent tenure, if not done in continuation of the first tenure, no chances for departmental permanent commission will be given.

Documents Required

4. At the time of joining, you are required to produce under mentioned certificates in original with a copy thereof for verification by Commandant /Commanding Officer:-

- (a) Higher Secondary / Birth Certificate for verification of date of birth;
(b) Internship Completion Certificate;
(c) Permanent Medical Registration Certificate;
(d) MBBS Degree/Pass Certificate; (Final/Provisional)
(e) PG Diploma or/ & PG Degree recognised by MCI, if applicable;

(f) Attempt cum Transcript Certificate.

5. Without the above certificates you will not be allowed to join service.

Ante-date Seniority

6. A candidate who has held an approved whole-time appointment in a recognised civil hospital for a continuous period of six months or more, OR is in possession of a Post Graduate Diploma in any branch of medical science recognised by the Medical Council of India, OR is in possession of a Post Graduate Degree such as Doctor of Medicine, Master of Surgery, or an equivalent or higher qualification, will be entitled for antedate of commission in accordance with Para 9 of AI 75/78, as amended.

7. If you are entitled for any antedate of commission in accordance with Para 9 of AI 75/78, as amended, you should submit your claim in accordance with the existing procedure soon after joining duty, OR latest within one year of joining service. Any antedate seniority granted will count only towards seniority promotions and not for back pay & allowances. You are advised to retain a copy of reference under which your antedate claim is processed till such time the claim is finalized.

Expected Time of Arrival (ETA)

8. Please inform the Commandant/Commanding Officer of the Unit where you have been posted of your expected time of arrival (ETA) so that necessary arrangement for your reception can be made.

9. You are advised to obtain prior permission of the Commandant / Commanding Officer of the unit before considering bringing your family to your duty station.

Reporting

10. **Current Medical Status.** On your initial/AMB/RMB medical examination you have been found fit by the Medical Board. However, you are required to undergo medical inspection on reporting to the unit mentioned against your name to simply confirm that there is no deterioration in your health status. In case more than 180 days have passed from the last medical examination, detailed medical examination (In AFMS-2) will be carried out again.

11. **Documentation.** You have to obtain a proforma regarding submission of your photographs and details of personal particulars from the Commandant/ Commanding Officer. The same, duly completed is required to be handed over along with the photographs for onward submission to DGAFMS/DG-1X (CRD Cell). You are also required to fill the proforma as laid down in Appendix 'A' to Army Order (AO) 3/2003 for release of your pay and allowances and submit the same to the Unit Office, for onward submission to the concerned CDA/paying office. You have to apply to the authorities concerned through proper channel for the issue of the Identity Card after your reporting for duty.

Change of Service, Date of Reporting or Unit

12. Please note that request for change of service, place of posting and extension of date of joining duty will not be accepted except in exceptional cases with the approval of competent authority.

13. **Inter Services Transfer.** Armed Forces Medical Services (AFMS) is a tri-services organization and you may be transferred from your parent service to any other service with change of uniform, based on organizational requirements whenever directed by the DGAFMS. However, any request from your side for change of service on personal grounds will not be entertained in the first three years of your commissioned physical service.

Unwillingness

14. In case you are unwilling to join the Armed Forces Medical Services (AFMS) on the basis of this offer letter, you are requested to intimate the same to the commandant/Commanding Officer under intimation to this office immediately through e-mail (dirafms-mod@nic.in) so that the next eligible candidate in the merit list could be offered appointment.

Separation From SSC

15. The minimum period of contractual obligatory service during the SSC is five years. Separation from SSC can be in the following two forms:-

(a) **Release.** An SSC officer can take release from SSC on completion of 05 years or at any time later if has been granted extension of SSC.

(b) **Resignation.** For an SSC officer to separate from service before completion of 05 years contractual obligation, he/she has to apply for resigning his/her Commission. However, it may be noted that resignation has many disadvantages. A candidate who resigns his Commission loses all his service benefits as well as the ex-serviceman status which allows him/her to avail age relaxation in applying for Central/State Government service. Candidates are, therefore, advised in their own interest not to resign their Commission.

Reserve Liability

16. On completion of the contractual service and release from service, you would be liable for reserve duty for a period of 5 yrs/after your date of release as per the provisions of the Army Instructions on the subject.

ATTENTION OF COMMANDANT/ UNIT CONCERNED

Medical Examination

17. (a) The initial medical board (whose validity is 180 days) in r/o these candidates were conducted in Oct/Nov 2022. The date of initial medical board of these candidates is mentioned against their name in the Appx (A) to this letter alongwith last date of validity of the same. It is requested that the detailed medical examination on AFMS-2 may please be carried out i/r/o those candidates whose validity of the initial medical board is lapsed on or before date of reporting. The candidates will not be allowed to join if found medically unfit and report to this effect along with a certificate will be sent to the Office of DGAFMS/DG-1A immediately. A copy of AFMS-2 i/r/o all candidates (whether found fit or unfit) reported for commissioning may also be forwarded to DGAFMS/DG-1A.

(b) Those candidates whose initial medical board is still valid on the date of reporting, they will not be subjected to medical examination board in reporting unit on AFMS-02. They are only required to undergo medical inspection on reporting to the unit to simply confirm that there is no deterioration in their health status. The candidates will not be allowed to join if found medically unfit and report to this effect along with a certificate will be sent to the Office of DGAFMS/DG-1A immediately. A copy of medical examination report i/r/o candidates reported for commissioning may also be forwarded to DGAFMS/DG-1A.

18. Reporting/Non-reporting of the candidates will be intimated by 10 May 2023 to concerned DGsMS immediately in the under mentioned format, who, in turn, will forward the same to DGAFMS/DG-1A in consolidated form. It may please be noted that delay in receipt of joining status results delay in allotment of MS Number which will adversely affect releasing the pay and allowances:-

(b) It is also requested that after the allotment of MS Number, DO Part II/Gen Form/POR in respect of the candidates commissioned be forwarded to concerned DGsMS & DGAFMS/DG-1A. It may be noted that delay in receipt of DO Part II/Gen Form/POR results in delay in releasing the pay and allowance and also in fwd the file to another section for further necessary correspondence.

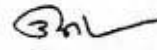

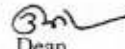
